- (1) Main contents of the organizational changes
 - Cut and Sew/Knits/Fabric Garments will be integrated into Tops Sec. to strengthen our total planning across the board, regardless of items. For Bottoms Sec., the age segments of Young/Career/Missy will be revised to strengthen planning without being bound by an age axis.
 - Relaxing Sec." and "Men's Sec." will be integrated (Relaxing/Casual Sec.) to strengthen the planning of casual products that transcend the boundaries between on and off duty and gender, in line with consumer trends, without being restricted to the conventional homeware (loungewear) and men's categories.
 - ◇ Account Group will be reorganized to strengthen planning and proposals for surface development to key clients.
 - ◇ Global Trade Group will be a region-based organization for EU/US/Asia to enhance business expansion in each region regarding both exports and imports.
